**Sunday October 15, 2017 – 10:00 am Start**

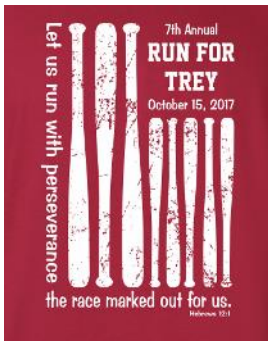
Same day registration starts @ 8:00am – Starin Park, Whitewater, WI
